**World Phone Internet Services Pvt. Ltd. Will Hold Press Conference
Explaining Its Action Against Facebook, Inc. and WhatsApp, LLC
On 3rd December 2021 at 12:30PM**

New Delhi, Delhi, India (1 December, 2021) – [World Phone](http://www.worldphone.in), India's premier VoIP service provider, today announced that it will conduct a virtual Press Conference on 3 December to explain why it has pursued its action against Facebook, Inc. – recently rebranded as "Meta", in the High Court of Delhi at New Delhi and what it seeks in the upcoming 6 December Hearing against Facebook, Inc. and WhatsApp, LLC.

World Phone's action (Writ Petition (Civil) No. 11173/2019) asks the Hon'ble Court to enjoin Facebook, Inc. and WhatsApp, LLC from providing Internet Telephony services until such time as they are in full compliance with the applicable requirements for providing such services in the Union of India.

These two US companies currently provide their Internet Telephony services to millions in India without any license or clearance from the concerned authorities. No different than regulatory decisions barring "discriminatory pricing" for different data platforms or content, World Phone's action seeks a ruling that levels the playing field for licensed operators such as World Phone.

Disregarding applicable law, Facebook messenger and WhatsApp currently operate in India without any underlying physical presence in India. The unregulated activities of Facebook, Inc. and WhatsApp, LLC can only be viewed as a form of digital colonialism that not only hurts companies such as World Phone but directly threatens our national security and our citizenry's autonomy, privacy, and sense of self-worth.
